2. Verify applicant is at least 18 years old.
3. Bring applicant to Club for review. Bring applicant to a Club sponsored shooting event. This is also a good time to introduce the applicant to members and ask three (3) members to sign the application and recommend the applicant for membership.
4. Be sure to have the applicant answer all questions and fill in all the spaces on the application.
5. Tell the applicant about work hours, stock ownership and dues.
6. Be sure that the applicant and you sign the application.
7. Bring the applicant to an Executive Board meeting for an interview and approval. This is a requirement before his/her application is voted on at a regular club meeting.

- New Member is required to perform 20 (twenty) work hours per year, for the first two years. Any hours not worked are charged \$10.00 per hour and a \$100.00 penalty is assessed for not fulfilling the work hour requirement. This is required for the first two years of membership. All subsequent years, Member is required to work 20 (twenty) hours per year and charged \$10.00 per hour for any work hours not worked.

PAYMENT: \$318.25 -- Due in full at the time of membership approval.
